WellStar provides ongoing training for student nurses in the Advanced Patient Simulation Center, a state of the art demonstration and training facility. During this training, the "patient" can be programmed to speak other languages. Student nurses are tested on their ability to identify the need for interpretation services and their understanding of the process to access interpretation services.

WellStar offers a wide variety of cultural competency workshops during the calendar year. Programs include: Patient Diversity-Beyond the Vital Signs, Bridging the Generational Gap at Work, Defining Respect in Healthcare, Diversity in the Workplace, and Multiculturalism at Work.
