Part A. 2: The interim hospital facility was operational all of 2008 (after being closed part of 2007 as a result of tornado damage that destroyed the original hospital building). Inpatient services did not resume until after the beginning of 2008.

Part C.1: As in previous years, Sumter Regional Hospital, Inc. managed the hospital facility in 2008 pursuant to a contract with the Americus & Sumter County Hospital Authority.

Part D.1: SUS beds in 2008 were less than the hospital's CON-approved complement of 143 beds.

Part D.6: The hospital did not utilize semi-private rooms in 2008.

Part G.1 and G.2: Due to ad hoc nature of hospital operations after 2007 tornado, the hospital did not utilize staff budgets in 2008.
