It is our understanding that Allied Health Staff, Technicians, Assistants/Aides (such as nurse aides), etc. are to also be included here - this is where we reported these types of staff. Also, what is the asterisk (\*) after "Registered Nurses (RNs-Advanced Practice)" for? We assumed that data on all RN positions were to be reported in this row.

# COMMENTS:

- (1) The completed questionnaire includes data only for Central State Hospital's Psychiatric Treatment Programs (Adult Mental Health Program and Child & Adolescent Mental Health Program). It does not include data for Central State Hospital's Forensic Services Program or Developmental Disabilities Services Program (ICFs/MR and Nursing Home).
- (2) PART D INPATIENT SERVICES SECTION transfers between the various programs/units of Central State Hospital (CSH) were not counted as admissions or discharges.
- (3) PART D INPATIENT SERVICES SECTION ITEM 4 PAYMENT SOURCE OTHER includes patients whose hospital care was covered by state budget/appropriated funds.
