### Part D: Inpatient Services

- The SummitRidge facility was sold and no longer part of the Gwinnett Hospital System as of September 2008. Therefore, the Gwinnett Medical Center in Lawrenceville no longer maintains an inventory of either Psychiatry or Substance Abuse acute care beds.

- The number of set up and staffed beds represents the current number of operational beds established as part of the recent opening of the new patient tower.

- Payment Source: State Merit is now included as part of the Third-Party primary payment source category. Historically, State Merit patients were included under the 'Other' primary payment source category.

- Operating Room - Average Charge for the First Hour: The Gwinnett Hospital System maintains numerous levels of initial hour operating room charges based on the resource intensity of anesthesia, staff and equipment involved in the case. Average provided is calculated on all case levels, including trauma, from actual patient charges.
