On December 7, 2009, the total number of AMH beds was reduced from 96 to 45 (15 Acute Care beds and 30 Extended Care beds). Prior to December 7, the total number of AMH beds during calendar year 2009 had been 96 (62 Acute Care beds and 34 Extended Care beds).
