Average provided is calculated based upon one hour of Level 3 OR charges.

Contracted services translated Korean for 262 hours and Vietnamese for 65 hours for Gwinnett Hospital System facilities. Physician language is currently not tracked for the entire medical staff. Nursing and other employed staff personnel are not utilized as interpreters.
