Part D.1.: In past years, Phoebe has broken out various sub-categories of general medical and general surgical beds. In this year's survey, Phoebe did not break out the sub-categories. The beds and associated utilization data that have been broken out in sub-categories in the past are included in either the General Medicine category or the General Surgery category in the 2010 survey.

E.4. Phoebe Putney information systems are unable to capture the type of Emergency Room visit by type of bed.
