Part F.1.b Starting on this survey, Hospice counts show Hospice patients in a hospital bed, and do not show activities of the Wellstar owned hospice called Tranquility.

Over the last few years, WellStar has enhanced interpretation services at all of our facilities in order to ensure effective communication and to provide culturally competent care. In-person medical interpretation services for patients who speak Spanish is now available at our two largest hospitals, Kennestone Hospital on a 24-hour basis daily and at Cobb Hospital, 8 hours/daily however all facilities have access to telephonic interpretation services which are available, twenty-four (24) hours daily with access to over 150 languages.

- Effective January 2012, Emergency Rooms were equipped with over 200 dual handset phones. Dual handset phones allow enhanced communication with patients with limited English proficiency (LEP). In addition to the emergency rooms, over 200 dual handset phones were already available in patient care units.

- Departments were trained on the use of these resources and how to document the use of interpretation services in patients' medical records. Additionally, an interpretation services toolkit was distributed to all departments. Information about CLAS Standards and detailed instructions on how to quickly access interpretation services are included in the toolkit and have been provided during department staff meetings and trainings.

- WellStar has also implemented programs to engage team members and train providers on how to provide culturally competent care. The Cultural Diplomat Program consists of WellStar team members of culturally and ethnically diverse backgrounds who offer insights, knowledge and cultural awareness to providers when they are confronted with cultural issues that may be impacting understanding during a patient's hospitalization or other patient care encounters. Review of the CLAS standards is an intricate part of this program. WellStar also has a monthly newsletter, Cultural Connections, which highlights a different culture dimension of diversity. In addition, WellStar offers additional online tools to support culturally competent care including the following:

- Culture Vision, a robust database that is geared to healthcare professionals. It provides cultural, religious and other information about several ethnic groups.
- DiversityToolkit , a resource designed for managers, leaders and front-line workers to help to successfully build and manage diverse workgroups.
- CareNotes provides inpatient/discharge information and drug-related information to patients. Information can be customized in multiple languages.
- Annual Diversity Forum – annual educational conference which focuses on diversity and cultural competency in health care. This conference is geared to all WellStar providers and system leaders.

A key component of the boarding process at WellStar is training of all nurses who have recently graduated from nursing school and are entering the workforce at WellStar.
