GGH, JDA & MCH). Annual updates are based on changing needs and is provided to staff on culturally & diverse populations that they may encounter. LodgeNet & Exitcare software has been added to the nursing component for individually assigned patient education on diagnostic education needs, advance directives and others. At the time of discharge Exitcare software allows the nursing staff to give the patient information to take home concerning their special needs in hardcopy in both English & Spanish.

**5.** What is the most urgent tool or resource you need in order to increase your ability to provide **Culturally and Linguistically Appropriate Services (CLAS)** to your patients?

International icons such as Mens & Womens bathroom are used throughout the system. There are no campus maps (hospital, out building services/departments, physician offices) in English or Spanish that can be provided in hard copy or on the web to patient/visitors. Directional signage is in English; if a patient/visitor was to enter on the East, West or South and did not speak English there could be a barrier. The most urgent tool needed is a software link that allows direct access (on the C.O.W.) for staff to immediately access the interpreter professional.
