On 6/1/15, the ownership of Tattnall Hospital Company, LLC (THC) was restructured pursuant to an acquisition by National Surgical Hospitals, Inc. (NSH), of all of the interests of Community Hospital Holding Company, LLC (CHHC). Pursuant to the transaction, CHHC became wholly owned by NSH Georgia, Inc., a Delaware corporation, which is wholly owned by NSH. CHHC then went from being the sole owner of THC to being the sole owner of certain business units owned by THC, but only a 51% owner in the hospital class of ownership which class owns Optim Medical Center - Tattnall. Additionally, Tattnall Chatham, LP formerly an indirect owner of THC pursuant to an ownership interest in CHHC, now became a 49% direct owner in the hospital class of membership units owned by THC which hospital class owns Optim Medical Center - Tattnall. Notwithstanding the foregoing,

THC remains the owner, operator, and manager of Optim Medical Center - Tattnell.
