Part E.4: The hospital used ICD10 codes to determine Trauma and Psych patients, used 0-17 for Peds patients, and all other were General ED beds for survey reporting purposes. The visit data reflect the types of cases that relate to the described bed/room type, regardless of where in the emergency department the patient visit took place. For example, the "Beds dedicated for Trauma" line item includes all trauma visits, including less severe trauma cases that were seen in general ED beds.

Part F.1.b Hospice counts show Hospice patients in a hospital bed, and do not show activities of Wellstar owned hospice facilities.
