Part E.1. - Top 10 Procedures: NDSC cannot track the true average charge for a given procedure as the overwhelming majority of patients in this facility undero multiple procedures in a single visit, and the charges for individual procedures cannot be separated out. As such, we have provided the top 10 procedures performed and the average charge for each procedure when that procedure was performed on a standalone basis only. Three of the CPT codes noted (15876, 15823, and 15830) were never performed on a standalone basis during the year. For these CPT codes, the average charge for all procedures performed on patients undgoing these procedures is provided. Part G.4. - Financial Table: "Other Contractual Adjustements" are net of bad debt.
