During FY 2012 Southern Regional Medical Center (SRMC) received funds on behalf of Morehouse School of Medicine related to the "Medicaid Rate Adjustment for Medical Education Georgia Board for Physician Workforce". These funds were transferred to Morehouse based on a signed agreement. During FY 2012 the total funds transferred to Morehouse were \$7,474,637.78. Because of the nature of the funds transfer, these funds are not recorded in the operating financial statements of SRMC.
