Part C: The number of operations reported in Q1 and Q2 total 437. This is forty eight (48) more than the patients/operations reported in Part C, Q4 and Q5; Part D, Q2; and Part F (389). This is because (i) the latter group is "open" patients only; and (ii) there were also forty eight (48) patients who had coronary bypass plus valves, aortic valve replacements, and/or mitral valve replacements during the same operation and were reported on both lines in Part C, Q1. Part D, Q1 through Q5: Total patient charges were used in all of these calculations. Part D, Q4: To prevent reporting a number that is constantly changing as patients get qualified for charity status subsequent to the discharge date, SJH includes all charity/indigent write offs on open heart patients that took place in calendar year 2011 regardless of patient discharge date.
